I have been advised by International Student Services of the following:

- My SNHU international student health insurance continues during my term off, but it does not cover me in my home country. I will be automatically billed for insurance for my term off upon my next registration.
- I must have a recent travel endorsement on my I-20 or DS-2019 form before traveling outside of the US.
- A valid F-1 or J-1 visa is required to return to the US, with the exception of brief travel to most bordering countries (Canada, Mexico, and some island nations).
- Absences in excess of one term from class will result in my need for new financial information, a new I-20 or DS-2019 form and the payment of another \$200 SEVIS fee.
- Absences in excess of 5 months from the US will result in my need for a new F-1 or J-1 visa even if my current visa is not expired.
- If living on campus I must notify Paula Shapazian in the Office of Residence Life to turn in my key and to learn the process and dates for moving back on campus after my term off.
